REAL ESTATE INDUSTRY HIKING RENTS FOR CASH

WHAT THEY GAVE

Over the last decade, real estate interests gave over \$62 million to support candidates in New York State elections.* In the 2014 election, members of the Real Estate Board of New York and their firms gave \$21.5 million—more than one-tenth of the money entering state elections.**

WHAT THEY GOT

In New York City, hundreds of thousands of rent-regulated apartments have been lost due to landlord-friendly laws that make it easy for landlords to hike prices, as well as a lack of enforcement of existing rules.

HEALTH INDUSTRY BLOCKING HEALTH CARE FOR ALL FOR CASH

WHAT THEY GAVE

Over the last decade, health industry interests including pharmaceutical, health insurance, and medical device companies gave over \$11 million to support candidates in New York State elections.*

WHAT THEY GOT

Health industry profits continue to soar while many New Yorkers can't afford the cost of getting covered. By contributing to candidates, the health industry helps block passage of the New York Health Act, which would provide guaranteed publicly funded universal healthcare to all New Yorkers.

HEDGE FUND BILLIONAIRES BLOCKING EDUCATION EQUITY FOR CASH

WHAT THEY GAVE

Over the last decade, Wall Street interests gave over \$38 million to support candidates in New York State elections.*

WHAT THEY GOT

Hedge fund billionaires have successfully campaigned to divert huge amounts of public resources into private schools.

Over the last decade, fossil fuel interests gave over \$5.5 million to support candidates in New York State elections.*

WHAT THEY GOT

For the sake of padding their profits, fossil fuel interests have blocked legislation to address climate change and create renewable energy jobs while also delaying recycling programs and fracking regulation.



BILLIONAIRES' TAX SCAM FOR CASH

WHAT THEY GAVE

Just seven billionaires gave over \$30 million in New York state and federal campaign contributions this election cycle.**

WHAT THEY GOT

These billionaires benefitted when the narrow Republican majority in the New York Senate blocked efforts to make the wealthy pay their fair share, including by closing the carried interest loophole.
